Rainforest Trust has committed 3.5 million USD to the ILC network to establish over 230.000 hectares of community-protected areas in Peru, the Philippines, and Indonesia while safeguarding over 80 threatened species.

Collaborating with the government, NLC Nepal is studying the climate crisis' impact on rural land, working to include tenure rights for women, landless people, Indigenous Peoples and local communities into the country's Climate Change Bill, as well as other national climate policy processes.

THE REAL PROPERTY.

Before the 2025 general elections, NLC
Bolivia will support peasant farmers,
Indigenous Peoples and local communities
to advocate for the passage of the "Bruno
Racua" law on the sustainable use of
the Bolivian Amazon. This proposed
law ensures the inclusion of Indigenous
Peoples and local communities in relevant
decision-making processes, including the
enforcement of FPIC.

SEIVEGA

Six multi-stakeholder consultations will integrate tenure security into land degradation neutrality targets and restoration frameworks for National Action Plans. Each consultation will produce an external report – to be presented during the 16th session of the UNCCD COP – and a methodological process for easy uptake in other countries.

JORDA

To fight desertification and implement Jordan's National Action Plan for UNCCD, NLC Jordan will support communities to establish a Hima – a sustainable pastoral land management approach - to protect traditional pastoral land and water harvesting locations.
